### **CRIMINAL BACKGROUND ASSURANCE**

Senate bill 730, effective August 1, 1983, amends Chapter 122 of the Illinois Revised Statutes by adding Paragraph 9 to Section 10-21. This amendment requires that all certified and noncertified applicants for employment with a school district are required to authorize an investigation to determine if such applicants have been convicted of any of the specified criminal or drug offenses.

Until such time that the Department of Law Enforcement has conducted an investigation of my background, I certify that I have never been convicted of: soliciting for a juvenile prostitute, juvenile pimping, exploitation of a child, child pornography, distributing or exhibiting harmful material to a child, criminal sexual assault, aggravated criminal sexual assault, criminal abuse, aggravated criminal sexual abuse, or violation of any section of the Cannabis Control Act or the Controlled Substances Act in this state or any other state.

I further stipulate and agree that the board of education shall not employ me in the event that the investigation indicates that I have been convicted of any of the felonies indicated, or if I have been employed my conviction record shall terminate my employment.
